TOURNAMENT RULES

MAIN SPONSORS



AGE LIMIT AND CATEGORIES

THE TOURNAMENT IS EXCLUSIVE FOR PLAYERS U-16 (BORN AFTER 01/01/1999), U-15 (PLAYERS BORN AFTER 01/01/2000), U-14 (PLAYERS BORN AFTER 01/01/2001) AND PLAYERS U13 (PLAYERS BORN AFTER 01/01/2002) THAT ARE AFFILIATED.

LOANS

THE LOANS ARE ALLOWED FOR A MAXIMUM OF 3 PLAYERS THAT COME FROM A DIFFERENT TEAM THAT DON'T PARTICIPATE ON THE TOURNAMENT. IN ANTICIPATION MUST BE PRESENTED THE DUE AUTHORIZATION FROM THE PLAYERS ORIGINAL TEAM. THIS AUTHORIZATION MUST BE PRESENTED TO THE TOURNAMENT ORGANIZATION BEFORE THE MATCH WHERE THE PLAYER WILL BE USED.

PLAYERS

THE TEAMS MUST PRESENT TO THE ORGANIZATION THEIR PLAYERS LIST BEFORE THE TOURNAMENT START (MINIMUM 15 PLAYERS; MAXIMUM 20 PLAYERS). ONCE THAT THE LISTS ARE DELIVERED IT IS NOT POSSIBLE TO MODIFY IT. BEFORE THE MATCHES A MAXIMUM OF 20 PLAYERS WILL BE IDENTIFIED.

SUBSTITUTIONS

A MAXIMUM OF 5 SUBSTITUTIONS ARE ALLOWED PER MATCH THAT CAN OCCUR AT ANY TIME.

QUALIFYING AND FINALS

THE 8 TEAMS WILL BE DIVIDED IN 2 GROUPS OF 4. ON A TOTAL OF 3 ROUNDS EACH TEAM PLAYS AGAINST THE OTHER 3 (MORNINGS AND AFTERNOONS ACCORDING TO THE SCHEDULE).

THE TEAMS THAT PLACE 2ND WILL DISPUTE THE 3RD AND 4TH PLACE. FOR THE FINALS WILL BE ELIGIBLE ONLY THE 1ST PLACED TEAM FROM EACH GROUP. **EACH TEAM PLAYS A MINIMUM OF 3 MATCHES.**

TABLES

THE TABLES WILL BE FIXED ACCORDING TO THE FOLLOWING CRITERIA: **3 POINTS PER VICTORY – 0 PER LOSS.** IF THE FINAL RESULT IS TIE (DRAW) PENALTY KICKS WILL TAKE PLACE. **THE PENALTY KICKS WINNER WILL SCORE 3 POINTS AND THE LOSING TEAM 1 POINT.** IF TWO TEAMS END UP THE GROUP

STAGE TIED IN POINTS WILL BE USED THE FOLLOWING CRITERIA TO THE UNTIE: 1) HIGHER NUMBER OF GOALS SCORED DURING THE GROUP STAGE; 2) LOWER NUMBER OF GOALS CONCEDED DURING THE GROUP STAGE; 3) RESULT ON DIRECT CONFRONTATION; 4) DRAW

IF MORE THAN TWO TEAMS END UP TIED THE GROUP STAGE THE FOLLOWING CRITERIA WILL BE USED FOR THE UNTIE: 1) DIFFERENCE BETWEEN SCORED AND CONCEDED GOALS; 2) HIGHER NUMBER OF SCORED GOALS DURING THE GROUP STAGE; 3) DRAW

MATCHES

THE MATCHES LAST FOR 2 HALVES OF 30 MINUTES EACH HALF. 11V11 ON FIELDS WITH THE LEGAL DIMENSIONS AND GOALS, BEING USED SIZED BALLS N°5. ADDITIONAL TIME WILL NOT BE APPLIED.

IF THE SEMIFINALS AND FINAL MATCH ENDS UP WITH A TIE, THE WINNER WILL BE DECIDED THROUGH PENALTY KICKS.

REFEREES

THE ORGANIZATION WILL PROVIDE OFFICIAL REFEREES FOR THE TOURNAMENT. IT WILL BE USED ONE REFEREE PER MATCH FOR THE GROUP STAGE AND THREE REFEREES FOR THE SEMIFINAL AND FINAL. NO PROTESTS WILL BE ACCEPTED. THE DISCIPLINE IS EXCLUSIVELY ADMINSTRATED BY THE SPORTS JUDGE THAT WILL BE PART OF THE *DELEGAZIONE PERIFERICA*.

THE SPORTS JUDGE WILL DECIDE REGARDING LESS THE TOURNAMENT DURATION, BEING ABLE TO DISQUALIFY ANY TEAM IF NECESSARY.

SANCTIONS

IF A PLAYER TAKES A RED CARD WILL BE AUTOMATICALLY OUT OF THE NEXT MATCH. HIGHER SANCTIONS CAN BE ALWAYS TAKEN BY THE SPORTS JUDGE.

THE PLAYERS ARE AUTOMATICALLY SUSPENDED FOR ONE MATCH AT THEIR 3RD YELLOW CARD BEING NOTICED BY THE SPORTS JUDGE.

COMPLAINTS

EVENTUAL COMPLAINTS HAVE TO BE PRESENTED UNTIL 30 MINUTES AFTER THE MATCH FOLLOWED BY A € 50,00 FEE. A COPY OF THE CLAIM MUST BE DELIVERED TO THE OTHER PART ALWAYS UNTIL 30 MINUTES AFTER THE MATCH.
